☑ Late Personal Property Lists - Sec. 137.345 of SB 62 requires the assessor to assess a penalty on any person who fails to return his personal property tax list by the first day of March.

**Do you own a Mobile Home?**In 1991, the Missouri Legislature passed House Bill 608, which states "Manufactured Homes (Mobile Homes)" shall be assessed as Personal Property, unless converted to Real Estate. Mobile Homes will continue to be valued by the same method, assessed at the same 19% of value, therefore this new law will not affect the amount of

- 1. If you own both the Mobile Home and the Land, the Mobile Home will be included on the Real Estate Tax Statement.
- 2. If you do not own the Land, where the Mobile Home is parked, the Mobile Home will be included on your Personal Property Statement.

If you own a Mobile Home, please complete the "Mobile Home" section on face of form.
